
This is in relation to the recent directive issued by the Securities and Exchange Board of India ("**SEBI**") setting out certain procedural formalities for companies proposing to undertake an initial public offering of equity shares, with respect to untraceable corporate records under the Companies Act, 2013 and the Companies Act, 1956.

Accordingly, in terms of the aforementioned directive and in respect of the proposed Issue and for disclosures in the Draft Red Herring Prospectus, Red Herring Prospectus and the prospectus (the "Issue Documents") to be filed with the Securities and Exchange Board of India ("SEBI"), the BSE Limited ("BSE") and the National Stock Exchange of India Limited ("NSE", together with BSE, the "Stock Exchanges") and the Registrar of Companies, we write to inform that certain errors or discrepancies made in the secretarial/ regulatory filings undertaken by the Company in the past. We confirm that these incorrect filings were made inadvertently and therefore, as a rectification measure and in good faith we are reporting these non-compliances to your office, for your record:


